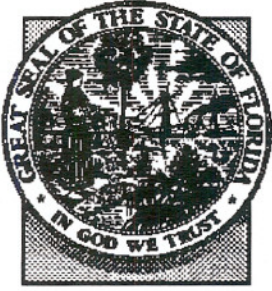
The Knights of Columbus is a registered Charitable Organization. See attached.
